**SECTION 5: FIRE FIGHTING MEASURES**

5.1	<b>Extinguishing Media:</b>	Flood with copious amounts of water. Do not use ABC fire extinguishers. Do not use dry chemicals, carbon dioxide, or halogenated extinguishing agents.
5.2	<b>Fire/Explosion Hazards:</b>	Negligible fire hazard. If heated by outside sources above 240°C (464°F) this product will undergo decomposition with the evolution of noxious gases but no visible flame. Wet materials may generate nitrogen trichloride, an explosion hazard.
5.3	<b>Fire Fighting Procedures:</b>	Consider evacuation of personnel located downwind. Keep unnecessary people away, isolate hazard area and deny entry. **SECTION 7: HANDLING AND STORAGE**
